#### Dear Colleagues,

Hospitals and Health care facilities who operate without consent & authorization or who's consent & authorization are not renewed are to face penal action from TNPCB. This was informed in a meeting with TNPCB Officials at its Headquarters in Guindy on 30/04/2019.

Meeting was attended by Mr.Thangapandian (Additional Chief Environmental Engineer), Mrs.Kavimoli (Assistant Engineer), Dr.S.karthick Prabhu (Secretary, NHB IMS TNSB), Dr. N. Muthurajan (Liason officer IMA).

TNPCB officials have also conveyed that the actions taken against erring facilities could range from very heavy fine upto closure notice served to hospitals. So dear colleagues we Team IMA 2019 request all hospitals to check whether their consent (Air & Water) and authorization from TNPCB is valid and live. Health care facilities, who have not applied, kindly do it immediately. This has to be done on war footing immediately to safe guard ourselves.

We have also requested TNPCB to send us the possible list of facilities without valid consent & authorization from their end & that shall be posted in our Tamilnadu IMA & NHB websites for your reference. It will be updated shortly.

We also request all District coordinators to coordinate with the hospitals in your district.

We request hospital owners to contact their respective DEE directly for the same. You can contact office bearers if you want any help in this regard.
