RESOLUTIONS PASSED IN
77th ANNUAL GENERAL BODY MEETING
HELD AT TEX VALLEY, ERODE
HOSTED BY IMA GOBICHETTIPALAYAM BRANCH
21.03.2021 – 03.30 pm

1. 77th AGM resolved to pass the resolutions passed in 76th AGM held in D'Way Farer Inn Resort, Erode on 22-12-2020 unanimously, proposed by Dr. S. S. Sugumar and seconded by Dr. V. Madhavan.
2. The audited statement of Accounts of IMA TNSB, audited M/S Subashini associates for the period from 01.04.2019 to 31.03.2020 were resolved to pass and approve to adopt unanimously by the Annual General body Meeting, as proposed by Dr. S.T. Prasad and seconded by Dr. Solomon D. Jeya.
3. The 77th AGM approved election announced for the posts for Chairman PPLSSS and Secretary, also Chairman FSS and Secretary and unanimously elected PPLSSS Chairman Dr. D. Chandrasekaran and Secretary Dr. P. Manivannan & FSS Chairman Dr. B. Venkatesan and Secretary Dr. Solomon D. Jeya. They will be taking over the charges w.e.f. 01.04.2021. The 77th AGM approved the nominations of Treasurer of PPLSSS Dr. N. Rajesh and FSS Dr. S.K. Anoop.
4. The 77th AGM authorised Dr. P. Manivannan and Dr. N. Rajesh to conduct financial transaction and operate the bank accounts of PPLSSS jointly from 01.04.2021 to 31.03.2023. Also Dr. Solomon D. Jeya and Dr. S.K. Anoop will conduct the financial transaction of FSS and operate the bank accounts jointly w.e.f. 01.04.2021 to 31.03.2023.
5. As per the resolution passed in the AGM of PPLSSS, it was resolved to pass unanimously by the General Body to revise the claim amount of PPLSSS from Rs. 5 L to Rs. 10 L with immediate effect, with an additional premium amount of Rs.1000/-. Similarly, the claim amount of Rs. 10L is increased to Rs. 20 L with immediate effect, with an increase of additional premium of Rs. 2000/-. The additional amount would be collected along with the forth coming premium for the existing members, the new members will pay the new amount when they join.
6. **Nomination of additional Trustees** : As three of the trust board members of PPLSSS, Dr. Capt. Raghavelu, Dr. T.N. Ravisankar and Dr. M. Balasubramanian resigned, it is resolved to pass unanimously by the General body not to accept the resignation of Dr. Capt. Raghavelu and to accept the resignation of others . It is also decided to nominate Dr. K. Prakasam, Past State President and Dr. M. Thiraviam Mohan past PPLSSS Secretary as trustees in place of resigned Trustees and the immediate past Chairman and the Secretary will be the trustees on rotation for two years, i.e. Dr. K. Thangamuthu, Chairman PPLSSS and Dr. Nehru, Hony. Secretary-PPLSSS will be the trustees on rotation for another two years, till 31.03.2023
7. The advisory committee of PPLSSS and FSS is to be consulted in all the activities of PPLSSS and FSS. And the new office bearers to get the help of them.

308th STATE COUNCIL MEETING
HELD AT TEX VALLEY, ERODE
HOSTED BY IMA GOBICHETTIPALAYAM BRANCH
21.03.2021 – 10.00 am

1. It is decided to enrol min. 50 members per branch to lead the country in the membership. IMA Branches to approach the nearest Medical Colleges and the corporate hospitals and enrol more members to IMA TNSB with the help of Junior Doctors network, through which the members can join IMA and pay the membership fee in 5 instalments.
2. IMA branches to establish more AMS and CGP Chapters in their branches.
3. The world record-Tirupur IMA Branch organised the camp of hair donation with 1113 members and collected 72.2 Kg of hair, and made a logo with the hair and donated, is appreciated by State council.
4. It is decided to thank the National President IMAHQs. for nominating more than 30 of our members in various posts.
5. The minutes of 307th State Council Meeting is passed unanimously by the members of the State Council, as proposed by Dr. A.M. Abul Hasan and seconded by Dr. N. Muthurajan.
6. The Kodaikanal SCM exp. for room rent was taken from the action fund, rest managed by the Cumbum Valley branch is passed.
7. It is decided once again to write a letter to all the Presidents of the branches to ask for a signature from the members who are in need of hard copy of TIMA Newsletter, in two months period. If the hard copy is to be printed, the PPLSSS office can come forward to help to print TIMA for all the members.

14. Dr. K. Thangamuthu is nominated by the State President as the Legal Committee Chairman for another two years.
15. Past State President, Dr. S. Kanagasabhapathy, Dr. R. Palaniswamy, State President Elect, Dr. S. S. Sugumar, Past State President, Dr. B. Sridhar, Immd. RESOLUTIONS PASSED IN
309th STATE COUNCIL MEETING
HELD AT HERITAGE MADURAI, MADURAI
HOSTED BY IMA CUMBUM VALLEY & MULLAI PERIYAR BRANCHES
18.07.2021 – 10.00 am

1. On Mixopathy, the order stating the House Surgeons to go for 1 week training and AYUSH Doctors to take the training for three months in modern medicine is to be opposed by IMA TNSB, resolution passed unanimously.
2. The minutes and the resolutions passed in 308th SCM held on 21 March 2021 at Tex Valley Erode has been approved by the State Council unanimously, as proposed by Dr. K. Prakasam and seconded by Dr. R. Gunasekaran.
3. The members donated generously for the action fund will be issued with the appreciation certificate.
4. A resolution passed unanimously to transfer the NATCON 2020 amount to IMA TNSB and keep the NATCON Account alive for to get few donations from the Pharmaceutical companies.
5. It is resolved to pass and approve the Statement accounts for the period from January 2021 to March 2021 unanimously by the State Council members, as proposed by Dr. K. Selvam seconded by Dr. K. Prakasam
6. Formation of New Branch IMA Kundrathur Matha Medical College Branch -
Proposed by Dr. Boopathy John Seconded by Dr. G. Maragathamani

7. The following was proposed regarding Eligibility of the candidates for IMA Election

A. Branch Elections :

- i. Notice for elections is given by the election officer appointed for the purpose, usually a senior life member of the branch, not necessarily an office bearer with a minimum of ten years as member of the branch.
- ii. The election officer is appointed by Executive committee/ Management committee/ General body, any one of the three as is prevalent in that particular branch.
- iii. Adequate time shall be given between announcement and the actual conduct of elections, usually fifteen days, with clearly stating the dates for last date of nomination, date of withdrawal and scrutiny- the pattern of state office shall be followed in this. It should be ensured that the information regarding the elections percolates to each and every member of the branch.
- iv. The post of president or secretary can be held only once as is practiced at the state level. The same person may contest for other posts but not for the same post which he or she has held before.
- v. For branches with less than 100 members, the post shall be held for a maximum of three years that too with the approval of the General body of the branch, but for branches with more than 100 members, the byelaws of the State constitution will apply which is one year for President and two years for the Secretary. If suitable candidate is not available or if nobody has filed a valid nomination, the election in charge shall call for fresh elections with new dates for nomination, last date etc. On no account, any office bearer will be allowed to hold the same office for a second term.
- vi. In case of any dispute or any supervision needed to monitor the election process, the respective branch shall contact it's zonal Vice President, who shall inform the State office and shall take up the responsibility of monitoring the election process either alone or along with another State office bearer and make sure that the election process is conducted in a fair manner to mutual satisfaction.

B. State Elections

- i. The candidates should have an impeccable record of integrity during their membership in IMA. This includes their services as office bearers in the local branch, State level as well as wings and schemes of IMA.
 - ii. In case the member is indicted directly or indirectly in any legal proceedings or/and included in the charge sheet filed by legal bodies, he or she will be considered ineligible to contest until the charges against them are cleared.
Further by explanation, directly will include allegations of being the accused or one of the accused. Indirectly will include collusion in execution of the crime and/or abetment of the same or having served as authorised signatories to a money laundering action with or without knowing.
 - iii. Legal proceedings will include civil/ criminal/ money laundering acts as described in Indian Penal Code. Legal bodies will include Police, court, Enforcement Directorate or any commission established by a legislature for the purpose of investigation.
 - iv. In case of the candidate raising a dispute doesn't follow the given protocol of approaching the state President with a written complaint , either as hard copy or as email from his registered email id, along with payment of fee for formation of an Appellate committee, and instead approaches a court of law for redressal, the same shall be considered as breach of constitution and the said candidate will be barred from contesting any future election for any post in IMA until the court case is decided and a firm verdict is given.
 - v. It is decided to conduct election from 7.00 AM to 7.00 PM, if required extend for another two hours till 09.00 PM.
8. Regarding the filling up of the District Coordinators Vacancies in the PPLSSS and FSS President and Secretaries of the concerned IMA will nominate and send a list to the Election Commission Chairman, who will finalise.
9. The following are the amended rules to conduct CGP courses:
- a. At a time, one person can appear for two courses only
 - b. One can take any number of courses
 - c. Duration of courses is only 6 months
 - d. Classes are on online and hands-on training through contact classes.
 - e. There will be a project given to all the candidates in the 4th month, and finish it by 5th month and give it for evaluation.
 - f. A log book must be maintained and assessed at the end of 6 months.
 - g. Out of 60 hrs of training, 48 hrs will be online classes (2 hours per week) and 12 hrs offline (Contact classes and hands on training).
 - h. Minimum attendance to appear for the examination will be 80%, including both online and offline classes.
 - i. If anybody failed and if the attendance is >80%, they can reappear by paying Rs. 5000/- as exam fee.
 - j. If the attendance is <80%, they have to attend the classes again paying 50% of the total fee.
 - k. Marks will be written-50, Oral-50, Clinical exam-50, Project submission-25 and Log book maintenance-25. Total marks will be for 200. A pass will be given by getting 50% in each section.
10. It is decided that the fee structure of Paramedical Course-Advanced Health Assistant (AHA) is amended with immediate effect, as follows.
- a. Admission fee in first year -Rs. 1000/-
Tuition fee for second year - Rs. 1000/-
Tuition fee for third year - Rs. 1000/-
Exam fee - Rs. 200/- per paper.
 - b. Paramedical Answer sheets: Leaving one year Answer sheets, rest can be destroyed.

AGENDA 08 : STATE PRESIDENT ADDRESS BY Dr. P.RAMAKRISHNAN :

Greeting the National President, IMA HQs, National Vice President, Past National and State Presidents and other leaders on and off the dais and the members, he thanked Mullai Periyar and Cumbum Valley branches for arranged this meeting in a short notice and their hospitality. He thanked all the branches for donated around Rs. 1.00 Crore to the Action fund, where Rs. 50 L were handed over to the Hon'ble Chief Minister of TN for the Covid relief fund. He thanked the CM for announced to give solatium of Rs. 25 L to the families of the deceased, thanked the Health Secretary for accepting the missing deceased members for issuing solatium.

Govt. of TN have invited IMA TNSB to attend the Doctors day function on 1st July 2021 and honoured us with the shield, for which the State President Dr. P. Ramakrishnan thanked the Govt. of TN. He also thanked IMA HQs. for announced solatium of Rs. 10L each and given to 4 of our deceased family. This year being an election year, Dr. N. Mohandas would announce the schedule of election. Congratulated the fact-finding team Chairman, Convenor and other members for done very good job and going to file charge sheet by the Police shortly.

On Mixopathy, the order stating the House Surgeons should go for 1 week training and AYUSH Doctors to take the training for three months in modern medicine is opposed by IMA TNSB, resolutionpassed unanimously.

On membership, we are in the second position having 36464 members, whereas the HQs. have the list of 37066, the State Secretary to clear the differences. AMS and CGP memberships are in 5th position having 1159 of 156692 and 1597 of 22250 respectively.

On financial status, we should have Rs. 74 Crores, whereas have only Rs. 54 Crores (PPLSSS-17C, FSS-22C, NHB-3.5X and State Office 5.5 C) in FD, the reason is the scam and the amount not collected in FSS.

Income taxes are being paid for consecutive three years now, hence we would get 12A exemption. Scrutiny on FSS II is on, and our auditor is answering the queries.

Last year Tamilnadu had 93 Martyrs out of 747 in the all India level and 54 of 203 this year.

Dr. K.Thangamuthu had saved around Rs. 2 Crores by answering replies to the cases: out of 103 cases last year, only3 had gone to the court. This year, out of 61 cases, 47 had been replies, rest in process. PPLSSS Secretary should explain the missing bank account, also when 14 PPLSSS members are due for

Rs. 50000/- ex-gratia, only one was given. He also requested the Secretary to increase the membership, by requesting the IMA branches.

FSS I had lost amount of Rs. 10 C by paying death claims amount Rs. 57 C , where collected only Rs. 47 C. The additional amount was taken from the reserve. Similarly, FSS II also lost around 2 C in paying death claim, which is taken from the reserve.

There was a communication from Directorate of Public health that the hospital have less than 50 beds should have Oxygen plants and the hospitals have Oxygen plants to increase the same within 6 months. DPH wants a progress in this regard.

AGENDA 09 : STATE SECRETARY REPORT BY Dr. A.K. RAVIKUMAR : Greeting the leaders on and off the dais and the members, he thanked the Mullai Periyar and Cumbum Valley branches for the excellent arrangement done to conduct State Council Meeting in Heritage Madurai.

a. ACTIVITIES OF STATE BRANCH : We had very tough time during the second wave of Covid, also the hospitals have been disturbed by the revenue department, where the State office guided the branches & written letters to the concerned collectors and resolved it. The shortage of Remdesivir was intimated to the Managing Director of TNMSC and the Health Secretary and got it supplied to the Private Covid care centres directly, hence the black marketing of remdesivir came down. There was a problem of shortage of bed for the Covid patients. As per the request of IMA TNSB and Govt. of TN, the NHB Nursing homes came forward to be part of COVID treatment, got empanelled and increased the number of beds and cooperated with the Govt. of TN. Similarly, shortage of Oxygen was at peak, we could manage and solve the issue with the help of Govt . Thanks to the Govt. of TN who accepted our request and raised the packaged rate of Covid treatment. Vaccinations are controlled by the Government, hence the private nursing homes are getting only 25%. The private nursing homes are getting vaccination through the Govt. portals only. We also informed the Govt. that IMA is ready to help the Govt. in giving vaccinations to the people in the remote area, when supplied by the Govt. Hon'ble Chief Minister of TN had announced and given solatium to the families of the deceased to the tune of Rs. 25 L. TN Govt. have forwarded the list of deceased Doctor's for Central Govt Insurance Amount , out of which 7 got Rs. 50 L as insurance. Covid relief fund have been collected and Rs. 50 L given to the CM as Covid relief fund and remaining would be spend for Covid related activities. Many practicing guidelines, treatment protocols were released time to time for the benefit of the members.

TNMC had summoned the office bearers of CGP for conducting different fellowship courses, where TNSB State President, State Secretary and the State Finance Secretary convinced TNMC and stated that the nomenclature of the courses would be changed as per the direction of National IMA.

The newly elected office bearers of PPLSSS and FSS have took over their office in the presence of State office bearers.

Every week Sunday between. 4-6 PM, State Presidents and Secretaries virtual meet is being conducted by the National IMA to discuss on various issues, program etc.

South zone NHB meet was organised and discussed core issues the Nursing homes face.

Virtual zonal meet of Paramedical wing was held, where the role of the Paramedics, their relationship with the patients, their experience, stress relief during this Covid pandemic was discussed. It was well organised by IMA TNSB Paramedical wing. Certificates were issued to the students passed out during 2019-20.

IMA team met Hon'ble CM and expressed our wishes on taking over as CM of TN. We also met the Hon'ble Minstar for health and expressed our greeting and gave memorandum to supply Inj. Remdisvir through TNMSC to Pvt. Covid health centers, revise old 2020 Covid treatment packages, vaccination distribution to IMA etc.

AGENDA 10 : STATE FINANCE SECRETARY REPORT BY Dr. N.R.T.R. THIAGARAJAN :

Greeting the leaders and the members on and off the dais, he had gone through the statement of accounts from 1-1-2020 to 31-12-20. Action fund: most of the income have come through the Covid martyrs relief fund. TNSB income of from the new life membership, he requested the members to approach the medical professionals and to join IMA. After the discussions on the previous SCM, TIMA Newsletter being sent to the members who is requesting for the hard copy, rest is issued with the e-TIMA. Natcon account is kept alive to get some more income from various sources, would be closed on receipt of the donations. Even the Covid have blocked the way of training programmes, the Academic cell courses have gone on online and fetched around Rs. 20 L, for which he admired the CGP team of IMA TNSB. Due to the regular continuing training programme for the Paramedics, we received around Rs. 20 L. Rs. 6 L have been arranged through Dr. C.N. Raja for Project committee. Through PPLSSS, FSS and NHB we get Rs. 1000/- per newly joining members. Benevolent fund have around Rs. 27000.

He explained in detail on action fund, IMA TNSB etc. The details also given in the agenda book. Unicef and end TB accounts are not closed, anticipating certain project in it.

FDs as on 1-1-2020 is 114 for Rs. 52914951 and as on 13-7-21, it is 44 FDs for Rs. 58647871. New FD creation in savings is Rs. 32L.

He also given the income and exp. for the period till 31-5-2021. The balance of Rs. 1,12,40,272/- is there in all the accounts.

He also thanked all the donors toward Covid relief work.

Dr. K. Selvam, IMA Kodambakkam : Can we get the tax exemption for the contribution we did for covid relief work? It is replied that the amount paid to the Hon'ble CM was by IMA TNSB, not by the individual, hence getting tax exemption is difficult.

Dr. R.V.S. Surendran, Past State President : Rs. 4.75 L refunded by Dr. K. Thangamuthu for conducted Medical Legal conclave, which is not reflexed in the presentation, Auditor fee is not mentioned, whenever a member die, PPLSSS used to give Rs. 50000/-, are we paying? IMA TNSB is taking loan from other schemes, how are you redeeming the amount? It is replied by State Secretary that the amount loaned from action fund have been paid back by the surplus amount in Academic cell and Paramedical fund, which is approved by the FSC. The only amount pending is for FSS. PPLSSS Secretary clarified that he could receive only one death claim for which he paid the amount, he did not receive the claim for the rest of the members. State President asked the PPLSSS Secretary to contact the concerned families and make the payment at the earliest. It is confirmed by the State President that a sum of Rs. 4.88L have come into the account of Medical Legal conclave.

Dr. K. Prakasam, Past State President:The NATCON amount to the brought to IMA TNSB. The branches which have not donated anything so far, can be requested to pay for action fund. It is clarified by the State Finance Secretary that certain amounts are expected from the Pharmaceutical companies, for which the account is not closed so far. Once the amount received, the amount would be merged to IMA TNSB and the account can be closed.

Dr. B. Venkatesan, FSS Chairman:Family of Dr. Jaffer was paid with FSS benefit amount, but his family is out of country, how could IMA TNSB have paid Rs. 2 L/-. State Finance Secretary said he would check and inform. Cheque has been sent to the Secretary Vaniambadi IMA to be handed over to the family and get Acknowledgement.

Dr. Boopathy John, Secretary-IMA Kodambakkam : The members have donated generously for the action fund, they can be issued with the appreciation certificate which would encourage them to do more donations in the future, which is accepted by the State President.

Dr. P. Ramakrishnan, State President: Is IT return over and got the acknowledgement? It is replied by the State Secretary that IT return for 2019-20 FY is over and got acknowledgement. We are about to submit the accounts to the Registrar of Societies. Necessary Demand Draft has been taken to submit to Registrar. He also said the accounts are almost ready to file IT for the FY 2020-21. State Finance Secretary said that there was not tax 2019-20 FY and won't be any tax in FY 2020-21.

AGENDA 11 : REPORT OF THE CHAIRMAN-FINANCE STANDING COMMITTEE DR. R. PALANISWAMY :

Greeting the leaders and the members on and off the dais, he had congratulated the Mullai Periyar and Cumbum Valley branches for the wonderful arrangements. Most of the observations made by the members are there is the FSC report. The sweep account would be closed after 3 months, if it is found to be not much use to us. He emphasised not to use the donation amounts for other purposes than it is collected for. The administrative expenditures can be met from the Academic cell and Paramedical accounts. It is also decided to transfer the amount of NATCON to IMA TNSB account and not to close the same until we get the amount which is promised to us. The academic cell courses are to be improved. TIMA is being supplied to all who is requesting for the hard copy, rest will get the E-TIMA, by which we are gained certain amount. Paramedical courses are going on well. There is no AMS courses going on now, it is to be initiated. Guest house in Tambaram is doing well. NHB Secretary office can have only two staff. FDs to be increase in increasing memberships. As we are paying Re. 1 L to HBI, no need of separate membership. He also congratulated Dr. S.G. Balamurugan, NHB Secretary who had collected more than Rs. 30 L for action fund. Advance amount to staff can be made on emergency and to be refunded short with shorter period EMI. MR letter to auditor is to be signed by the concerned office bearers. FSS is doing well. HPS and FBS are doing good. Guest house in Chetpet and JVL plaza is also doing well, getting good income.

Dr. B. Venkatesan, Chairman FSS& Dr. K. Prakasam, Past State President : A clarification asked on the operation of the Sweep account. FSC Chairman said, in IMA TNSB account if the amount is more than minimum basic we have suggested the excess will be coupled with the sweep account, by which the excess amount is made FD automatically and will fetch interest. Whenever there is a shortage of fund in IMA TNSB to clear certain cheque etc., the amount in temporary deposit will Sweep back for payment and will revert back as temporary deposit as and when enough fund is there. We could get around Rs. 22000/- as interest, but the problem is that we don't understand fully the transaction and have confusions. Hence we wait for 3 months till we familiar with, unless it will be closed.

Dr. S. Karthick Prabhu. Asst. Secretary: The sweep account fetches more interest and helps in case of shortage in the main account. Hence, sweep account may be continued to get more interest amount. Dr. R.V.S. Surendran said, we have to monitor the operation of the sweep account, otherwise mayleadto over expenditure. After 3 months, a report may be submitted on the subject. Dr. K. Selvam appreciated the Sweep account and suggested the sweep account, even for all the other accounts. Dr. Boopathy John cautioned that the deposit amount could be taken by the Govt., hence it is better to discuss with the auditors and the lawyers.

State Secretary announced, NATCON Scientific session have been given with 4 credit hours and those who attended and wants credit hrs can pay Rs. 200/- to NATCON account and avail the same.

Dr. M.S. Ashraf, Past State President: Almost a year passed and the NATCON 2020 account is not closed. As decided in the FSC Meeting, the amount in NATCON account may be transferred to IMA TNSB account and announce the Pharma company name through TIMA. State Secretary said that he had written letter to the Hony. Secretary General, who promised to get the donations from the non paid Pharma companies and give it to NATCON 2020 account.

A resolution passed unanimously to transfer the NATCON 2020 amount to IMA TNSB and keep the NATCON account alive for to get few donations from the Pharmaceutical companies.

Dr. K. Prakasam, Past State President: The LM fund is to be send to the HQs immediately. A separate account is to be maintained for the same. No borrowing is accepted.

Dr. Alagavenkatsan, IMA Madurai: An appreciation / thanks letter may be sent to the branch/individual for the Covid donation that they made.

Dr. R. Anburajan, CGP faculty Secretary: Like NHB, IMA TNSB CGP may be allowed function independently, so as to function efficiently. Hony. State Secretary said will need discussion before we consider the request.

Dr. R. Gunasekaran, Past State President: When there is a CGP wing, why there is a separate academic cell to conduct the courses? It is better IMA TNSB CGP to conduct the courses and report to National CGP.

AGENDA 12 : CONSIDER AND ADOPT THE STATEMENT OF ACCOUNTS OF IMA TNSB FOR THE MONTH OF JAN 2021 TO MARCH 2021.

It is resolved to pass and approve the Statement accounts for the period from January 2021 to March 2021 unanimously by the State Council members, as proposed by Dr. K. Selvam seconded by Dr K Prakasam.

Dr. S.S. Sugumar, Past State President: He asked the clarification whether of his name and Dr. N. Mohandas name included in the attendance of 307th SCM held on Hybrid from Chennai on 12-12-2020. It is confirmed by the State Secretary that both Dr. S. S. Sugumar and Dr. N. Mohandas names were included in the attendance of 307th SCM.

REPORT OF THE CONSTITUTIONAL AMENDMENT COMMITTEE CHAIRMAN DR. S. KANAGASABHAPATHY:

There are certain constitution amendments proposed by the Constitution amendment committee, the members can suggest to approve, amend, so as to make a fair of amendment and publish in TIMA, before we print a new Constitution book. **Page-9; Sec-4 ; Sec- 2(a)**

Notice for elections is given by the election officer appointed for the purpose, usually a senior life member of the branch, not necessarily an office bearer with a minimum of ten years as member of the branch. The election officer is appointed by Executive committee/ Management committee/ General body, any one of the three as is prevalent in that particular branch.

Adequate time shall be given between announcement and the actual conduct of elections, usually fifteen days, with clearly stating the dates for last date of nomination, date of withdrawal and scrutiny- the pattern of state office shall be followed in this. It should be ensured that the information regarding the elections percolates to each and every member of the branch.

clause - 3(a)

The post of president or secretary can be held only once as is practiced at the state level. The same person may contest for other posts but not for the same post which he or she has held before.

For branches with less than 100 members, the post shall be held for a maximum of three years that too with the approval of the General body of the branch, but for branches with more than 100 members, the byelaws of the State constitution will apply which is one year for President and two years for the Secretary. If suitable candidate is not available or if nobody has filed a valid nomination, the election in charge shall call for fresh elections with new dates for nomination, last date etc. On no account, any office bearer will be allowed to hold the same office for a second term.

In case of any dispute or any supervision needed to monitor the election process, the respective branch shall contact it's zonal Vice President, who shall inform the State office and shall take up the responsibility of monitoring the election process either alone or along with another State office bearer and make sure that the election process is conducted in a fair manner to mutual satisfaction.

Page- 36 : Eligibility of the candidates

The candidates should have an impeccable record of integrity during their membership in IMA. This includes their services as office bearers in the local branch, State level as well as wings and schemes of IMA. *In case the member is indicted directly or indirectly in any legal proceedings or/and included in the charge sheet filed by legal bodies, he or she will be considered ineligible to contest until the charges against them are cleared.*

Further by explanation, directly will include allegations of being the accused or one of the accused. Indirectly will include collision in execution of the crime and/or abetment of the same or having served as authorised signatories to a money laundering action with or without knowing.

Legal proceedings will include civil/ criminal/ money laundering acts as described in Indian Penal Code. Legal bodies will include Police, court, Enforcement Directorate or any commission established by a legislature for the purpose of investigation.

To add as explanation

In case of the candidate raising a dispute doesn't follow the given protocol of approaching the state President with a written complaint , either as hard copy or as email from his registered email id, along with payment of fee for formation of an Appellate committee, and instead approaches a court of law for redressal, the same shall be considered as breach of constitution and the said candidate will be barred from contesting any future election for any post in IMA until the court case is decided and a firm verdict is given.

Dr. R.V.S. Surendran, Past State President: As per the National IMA constitution, the branches to have the separate Constitution based on the model constitution of National IMA and those who don't have to follow the HQs. constitution. In case, if we make the separate constitution for the branches, will it not be contra to the National IMA Constitution. The model constitution of IMA Hqs. is to be followed by the branches. There are branches have constitution before we frame constitution for IMA TNSB. He wants IMA TNSB is to take a permission of Central council for the state model constitution. State Secretary clarified that there are branches do not have constitution, there is a committee formed which will give model constitution based on the National IMA Constitution and the State IMA.

He suggested to change the resolution passed vide no. 17 of 308th SCM held at Erode that a member whose name appear in the charge sheet should not be allowed to contest the election instead of request not to contest. If allowing a member whose name is there in the charge sheet, contest and win, but convicts by the court will bring bad name to IMA.

Dr. Alagavenkatesan, IMA Madurai: A members whose name appear in the charge sheet should not be allowed to contest and not to request. Making constitution for the branches should be as per the model Constitution of National IMA and get the approval of Central Council.

Dr. C.N. Raja, Past State President: Constitution amendment committee Chairman is presenting, the changes planned to change by the committee, it is up to the members to accept or reject. The same will be circulated in the TIMA Newsletter, the members can forward their suggestion before making it final and take the approval of the General body.

Dr. P. Ramakrishnan, State President : *Constitution amendment committee Chairman shared points to be amended in the constitution. The suggestions of the members are well taken. A legal opinion will be sought before it brought out to the members once again.*

Dr. S. KANAGASABHAPATHY, PAST STATE PRESIDENT/CHAIRMAN-FACT FINDING COMMITTEE :

The charge sheet is about to be filed shortly. A copy of the charge sheet will be given to IMA. We will have a GB meeting where we will discuss and finalise the next course of action.

Dr. Bharathy Selvam, IMA Chidambaram: So far, the fact-finding information is informed orally and not through the letter pad.

Dr. C.N. Raja, Past State President: The fact-finding information are shared in every meeting hours together by the Chairman, Convenor and other members which is already recorded in the minutes. He requested the members not divert the other members with irrelevant information. He condemned the statement of the members that the fact finding information is not shared to the members.

Dr. A.K. Ravikumar, Hony. State Secretary: State Council meeting is to be attended by the branch President, Secretary and the State Council members who would disseminate the information what is discussed. Also, the whole information discussed is been minuted and issued to the State council members.

Dr. J.A. JAYALAL, NATIONAL PRESIDENT, IMA HQS.: Wishing the gathering, he said, IMA is taking up the issues of Medical fraternity and the public and all the levels. Hon'ble Prime Minister had joined the Doctors day celebration and gave the positive note on the service of the Doctors. Supreme Court Judges are also appreciated the service of the Doctors. Leaving the problems, we must show our positive service to the public. 563 Doctors have died due to Covid. An Act against the violation of the Doctors would be brought soon by the Govt. The family Physicians served more than 20 years and released research papers would be recognised and given recognition. Covid martyrs fund is being issued to 23 families each 10 L, out of which one lady Doctor from Ambasamudram. He requested the members to contribute generously for the noble cause, as still many are waiting to get this solatium. 4. He thanked National President for helped 4 families of Covid Martyrs.
5. Appreciated Fact finding team for their sincere work, time spend with Police and court etc. He requested the members not to discourage the fact finding team.
6. Thanked State office for formed a Patient redressal forum-Crisis management committee.

Secretary said the patient to pay Rs. 15000/- for oxygen whether in room or general ward.

Dr. Kallilur Rahman, Representative, Biomedical Waste Management: Steps are being taken to get approval to establish Bio medical waste plant at Ramanathapuram. Site plan and other certificates are obtained. Applied for ground water certification at PWD.

Dr. Nirmal Fredrick, Chairman Academic Committee: We had conducted 5 webinars with ARC. Similar programme is planned for coming months also. We had sent 3 articles to JIMA. We will come out with the contact programmes of CME once the lockdowns are lifted.

AGENDA 19 : REPORT OF IMA NHB :

Dr. B. Sridhar, Chairman NHB: The App initiated by previous office bearers have come to the final stage and we are inaugurating a NHB App. National President and State President both inaugurated *IMA NHB app*.

Dr. S.G. Balamurugan, Secretary IMA NHB: The features in the website is also available in the NHB App. Registration and renewal can be done through this app with online tracking system. One can view the name of the Doctor, mobile number, e mail id and registered member. Send the queries and message via this app and to get answer from office bears and experts. Mail to NHB Office. Downloading all PPT and video of all scientific sessions. Notification and Govt. G.Os available.

The following are the resolution passed in the past Management Committee meeting.

1. G.O 251 dt. 23-5-2021. CMCHIS Covid package- the rate for mild cases is low and it should be increased.
2. Retrograde approval- that is asking the hospital to send approval after discharge/death cases in CMCHIS scheme should not be done.
3. All the temporarily empanelled hospitals in CMCHIS for COVID treatment to be allowed to treat general cases and permanent empanelment status to be given.
4. We should represent the Govt. for a better package for all specialities in CMCHIS and TNNHIS (Govt. employee Scheme).
5. We should represent to the Minister for local administration regarding uniform property tax all over the Tamilnadu and the recent hike in Chennai to be dropped.
6. We should represent the Minister for Electricity regarding reducing the EB tariff rate as per MSME norms.
7. We should represent the Director of DTCD regarding building norms for small hospitals to be changed and it should be Doctor friendly.
8. We should represent the Director of Fire safety services to change the validity period of the fire safety certificate from on year to five years.
9. We should represent the labour commissioner to direct the district officials to abeyance the minimal wages act. G.O dated 2-3-2018 and insist formation of the new committee for new guidelines.
10. We should represent the Director of Pollution Control board regarding the direction to be given to the Bio medical waste management agency to remove the Bio medical waste daily without any delay.

It is clarified the biomedical waste collection rate for covid waste is apart from the normal fee.

Dr. V. Varadharajan, NHB convenor:This application will overcome some problems. The biomedical wastes are to be paid on volume based for corona wastes. As the problems are increasing day by day, certain extend this app will help us to solve. We are one step ahead to serve the community by using this app. It is clarified the wages to labours are kept in abeyance.

Dr. R. Anburajan: It is observed the fee collected for biomedical waste is per day per bed as well as wastes per kg in case of covid, it is to be taken up.

Dr. S. Karthick Prabhu: Once CEA is in force, D&O license should not be there.

REPORT OF AMS : Dr. V. Amuthan, Chairman, AMS:AMS chapters are there in Madurai and in Coimbatore, we are also going start it in Tambaram and Tirunelveli. We had conducted symposium on recent trends in Neuro Science on 21-4-21, Symposium on recent trends in Pulmonary Hypertension on 26-5-21, another symposium on Mucormycosis and Covid 19 pandemic 16-6-21, Symposium on Covidology for OGcian on 14-7-21. We are organising South Zone conference of IMA AMS on 12-9-21 we are going conduct 5 course on that day. He requested all the members to attend the meeting and the course, no registration fee.

REPORT OF CGP : Dr. A. Govindrajan, Director of Studies CGP:He thanked the office bears of State office settled the issue raised by TNMC against the CGP courses conducted by IMA TNSB. He also thanked the president TNMC. He requested all the Branch President and Secretaries to encourage the members to join CGP.

Dr. R. Anburajan, Faculty Secretary, IMA TNSB CGP:After consulting with the State President, State Secretary and the faculties, we have developed certain new rules and regulations. The Mental health courses

will be on online and the practical classes will be from Madurai. Diabetic foot care course will be started soon.

1. At a time, one person can appear for two courses only
2. One can take any number of courses
3. Duration of courses is only 6 months
4. Classes are on online and hands-on training through contact classes.
5. There will be a project given to all the candidates in the 4th month, and finish it by 5th month and give it for evaluation.
6. A log book must be maintained and assessed at the end of 6 months.
7. Out of 60 hrs of training, 48 hrs will be online classes (2 hours per week) and 12 hrs offline (Contact classes and hands on training).
8. Minimum attendance to appear for the examination will be 80%, including both online and offline classes.
9. If anybody failed and if the attendance is >80%, they can reappear by paying Rs. 5000/- as exam fee.
10. If the attendance is <80%, they have to attend the classes again paying 50% of the total fee.
11. Marks will be written-50, Oral-50, Clinical exam-50, Project submission-25 and Log book maintenance-25. Total marks will be for 200. A pass will be given by getting 50% in each section.

Dr. C.N. Raja, Immd. Past State President : As we are under National IMA, let us use the nomenclature given by National IMA for CGP courses, no need to change the nomenclature. Already National President asked, why was the nomenclature of the courses changed?. So no need to change the nomenclature of the courses. Last year we had received a similar letter and we had replied suitably.

Dr. J.A. Jayalal, National President, IMA HQs.: As we got the clearance from the National Medical Commission, Fellowship Certificate Course can be conducted. A course conducted under IMA CGP HQs. it is coming under the purview of Delhi. Hence, we have to issue certificates as Fellowship only.

Dr. K. Prakasam, Past State President: TNMC can write to NMC, and NMC can direct IMA HQs. for and change in the decision. TNMC should have issued notice to the State Secretary and not to CGP faculty Secretary Dr. R. Anburajan and Director of studies Dr. A. Govindarajan.

Dr. R. Palaniswamy, State President Elect: Are we going to conduct the courses by the name of Academic cell courses or CGP?. We have to come under IMA CGP HQs. to issue Fellowship certificates.

Dr. N.R.T.R. Thiagarajan, State Finance Secretary: According to NMC, FRCS is a recognised PG degree. Hence similar PG Degree courses should not be used here.

Dr. J.A. Jayalal, National President, IMA HQs.: FRCS is not Fellowship, it is the fellow of the royal college of General Practitioner. Any organisation can give fellowship certificate. Dr. Swaminathan, IMA Neyveli: TNMC should have issued notice to the President /Secretary of IMATNSB not the lower levels.

Dr. C.N. Raja, Immd. Past State President: State president IMA TNSB can write a letter to National IMA to get the clearance to use the name Fellowship.
