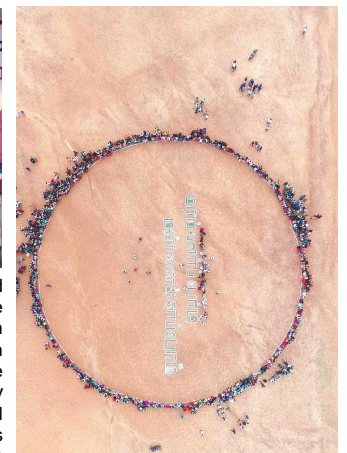

We have taken all steps right from the reveal of the scam, to the present filing of the case and chargesheet. We are following it up on a day to day basis and hope that it would finish at the earliest.

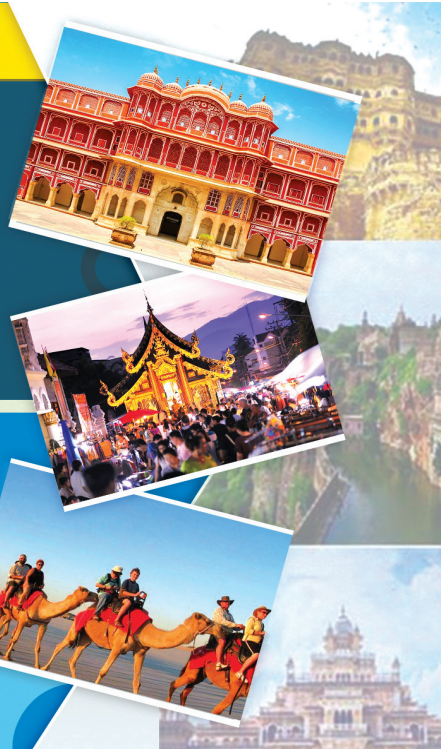

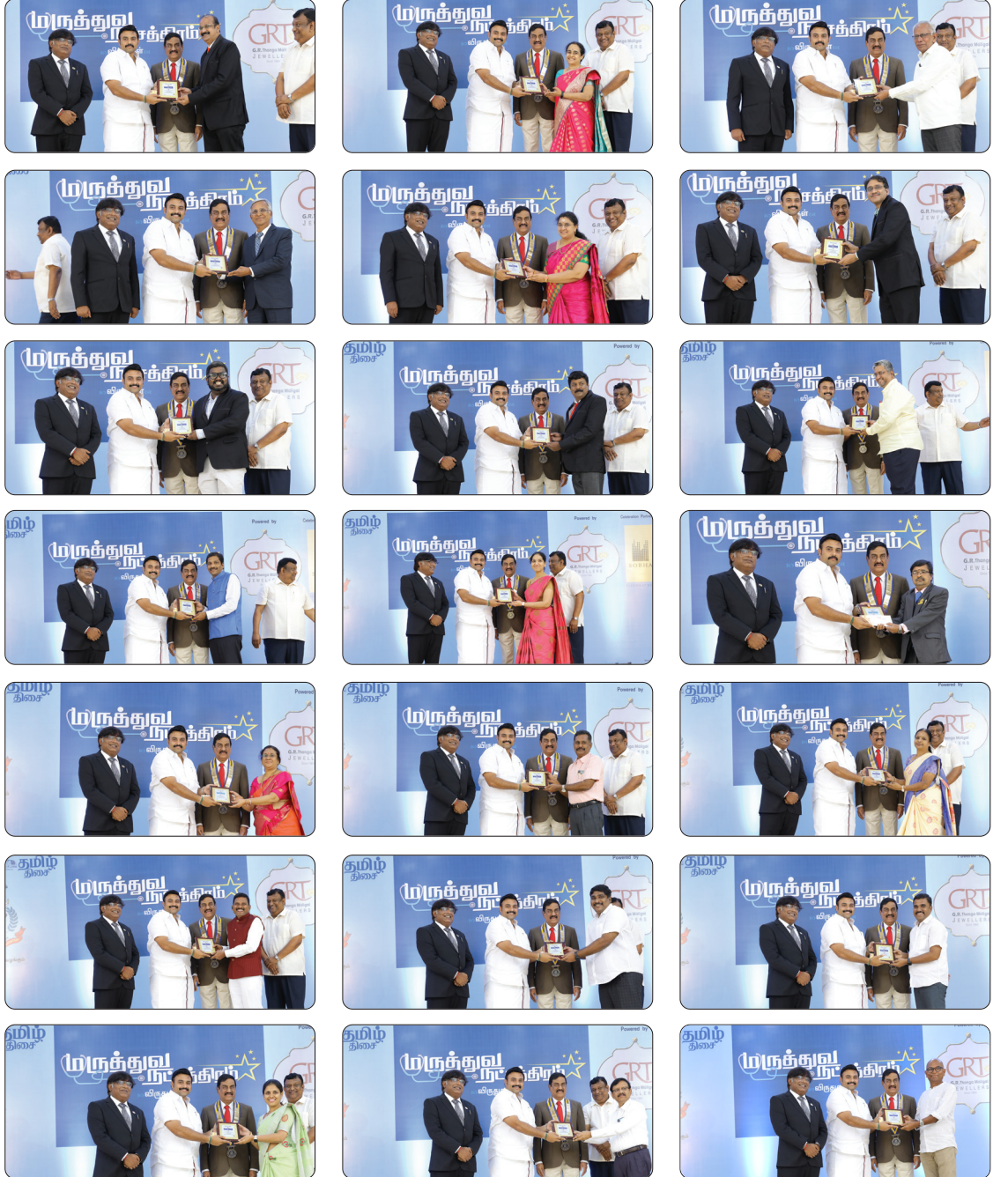






















## IMA CGP TNSB ONLINE / OFFLINE COURSES

# NURSING HOME BOARD

**Dear Doctor's Greetings from NHB IMA TNSB!**

**Minimum Wages :** Our Chairman Dr. S. Karthick Prabhu and Finance Secretary Dr. R. Rengaraj went to the Labour Secretary's Office to persuade. But couldn't able to meet the Labour Minister.

**Insurance :** ASI office bearers with State NHB Chairman Dr. S. Karthick Prabhu and Dr. R. Rengaraj met Hon'ble Tamil Nadu Health Minister Mr. M. Subramanian, Health secretary Mr. Senthikumar & Finance Secretary Mr. Muruganand on 16<sup>th</sup> September. We presented our grievances & working cost analysis for surgeries under CM insurance, Govt employees & Pensioners scheme. Requested for appropriate action for revision of tariffs. All three of them were very receptive. We need to follow up with multiple representations with all your collective support.

## Our Demands

- 1) General revision of package rates to a minimum of 200% hike from the current rates which closely match's the minimum costing packages delivered.
- 2) Hospitals are presently categorized into 6 types and we have requested to reduce into 3 categories, which makes it more easier for hospitals to comply.
- 3) Some treatments and surgeries are allowed only in government hospitals to abolish that and to have a single package system for both Govt and Private Health Care Centre.
- 4) We are requesting 20% hike in package rate for the NABH accredited hospital. We require this to compensate for costs incurred to implement the NABH standards.

We are planning to have a high-level Insurance Conclave with all the Insurance companies in January 2023.

**BMW :** It has been decided to ask the Facilitators to maintain the rates already accepted by them in the Coordination Committee held in Tanjore on 9<sup>th</sup> October 2021. Every hospital should sensitize their hospital staff for proper segregation of BMW. We are taking steps to eliminate pure consulting rooms from consent and authorization. Recent inclusion of 18% GST on BMW may cause increase in rate. Planning for another facilitators meeting on this regard in October 2022 itself.

**Appointment of Dist. Coordinators :** 36 District Coordinators were appointed. 2 districts remain unfilled (Nagapattinam & Tiruvarur). The Roles and Responsibilities along with the list of member hospitals were communicated to them. We are having a Plan to have a State wide District Coordinators Training in November 2022. The Presidents and Secretaries of the Nagapattinam and Tiruvarur IMA branches are requested to nominate suitable district coordinators.

**Udyam Registration :** Hope you are aware that from last two years, hospitals have been brought under service sector of MSME by our central government. It entails you to subsidized bank loan and such other facilities. We as an organization can approach TNEB for concession in tariff.

Whenever we approach the bank for a hospital related loan they also advise us to get MSME certificate so that they can subsidize the loan (solar power). The process is very simple. You have to search and login to "Udyam registration" in Google There's no cost involved, only a procedure which will require you to submit details of IT returns (latest), assets value (as officially declared by you), details of your organization, staff and manpower. It may take a few days, you will receive the registration through email and you can generate your certificate. I request all hospital owners and NHB members to register their health care facilities with MSME immediately

51. As we have noticed hereinabove that the cases of doctors (surgeons and physicians) being subjected to criminal prosecution are on an increase. Sometimes such prosecutions are filed by private complainants and sometimes by police on an FIR being lodged and cognizance taken. The investigating officer and the private complainant cannot always be supposed to have knowledge of medical science so as to determine whether the act of the accused medical professional amounts to rash or negligent act within the domain of criminal law under Section 304A of IPC. The criminal process once initiated subjects the medical professional to serious embarrassment and sometimes harassment. He has to seek bail to escape arrest, which may or may not be granted to him. At the end he may be exonerated by acquittal or discharge but the loss which he has suffered in his reputation cannot be compensated by any standards.

52. We may not be understood as holding that doctors can never be prosecuted for an offence of

which rashness or negligence is an essential ingredient. All that we are doing is to emphasize the need for care and caution in the interest of society; for, the service which the medical profession renders to human beings is probably the noblest of all, and hence there is a need for protecting doctors from frivolous or unjust prosecutions. Many a complainant prefers recourse to criminal process as a tool for pressurizing the medical professional for extracting uncalled for or unjust compensation. Such malicious proceedings have to be guarded against.

53. Statutory Rules or Executive Instructions incorporating certain guidelines need to be framed and issued by the Government of India and/or the State Governments in consultation with the Medical Council of India. So long as it is not done, we propose to lay down certain guidelines for the future which should govern the prosecution of doctors for offences of which criminal rashness or criminal negligence is an ingredient.

A private complaint may not be entertained unless the complainant has produced prima facie evidence before the Court in the form of a credible opinion given by another competent doctor to support the charge of rashness or negligence on the part of the accused doctor.

The investigating officer should, before proceeding against the doctor accused of rash or negligent act or omission, obtain an independent and competent medical opinion preferably from a doctor in government service qualified in that branch of medical practice who can normally be expected to give an impartial and unbiased opinion applying **Bolam's test** to the facts

A doctor accused of rashness or negligence, may not be arrested in a routine manner (simply because a charge has been leveled against him). Unless his arrest is necessary for furthering the investigation or for collecting evidence or unless the investigation officer feels satisfied that the doctor proceeded against would not make himself available to face the prosecution unless arrested, the arrest may be withheld.
